Subject: Surge Capacity Fixed Wing Aircraft Mobilization and Utilization Direction

The USDA Forest Service is augmenting the National Exclusive Use Fixed-Wing fleet with five (5) Large Airtankers, (2) CL-415 Amphibious Water Scoopers, and five (5) Air Tactical Fixed Wing aircraft.

These National Resources will be available on a daily basis for the identified contracted time period and any extensions (if required). Availability for these resources is paid for by the Forest Service National Office and will not be charged to incidents.

All surge capacity Fixed-Wing aircraft will be prepositioned, utilized, and mobilized in accordance with the National Multi-Agency Coordinating Group (NMAC) Strategic Considerations for Geographic Capability and Prioritization Criteria, regardless of national planning level.
